

# THE UNITED FRONT OF ETHIOPIAN FEDERALIST AND CONFEDERALIST FORCES

## Grand Agreement among:

1) Afar Revolutionary Democratic Unity Front, 2) Agew Democratic Movement, 3) Benishangul People's Liberation Movement, 4) Gambella People's Liberation Army, 5) Global Kimant People's Right and Justice Movement/Kimant Democratic Party, 6) Oromo Liberation Front-Oromo Liberation Army, 7) Sidama National Liberation Front, 8) Somali State Resistance, 9) Tigray People's Liberation Front.

- A. Announcing the establishment of the United Front of Ethiopian Federalist and Confederalist Forces;
- B. Recognizing the agreement between the Oromo Liberation Front-Oromo Liberation Army and the Tigray People's Liberation Front;
- C. Recognizing the shared beliefs among all organizations, and our mutual struggle for democracy, equality and self-determination;
- D. Nothing the fast deteriorating security and political situation of the country and the deliberate attempts of the regime in Addis Ababa (Finfine) to drive Ethiopia into an all-out internecine war;
- E. Recognizing the responsibility of all organizations to ensure that the country goes through a peaceful transition in the aftermath of the demise of the current Ethiopian regime;
- F. Cognizant of the constructive and positive influence the coordinated and cooperative relations between our organizations have on the political environment of the country, and the much anticipated National Dialogue, we have agreed on the following:
  - 1. Agreed to coordinate on multifaceted efforts in the ongoing struggle against the regime in Addis Ababa (Finfine);
    - 1.1. All parties have agreed to establish a joint command responsible for all round activities,
    - 1.2. All parties have agreed to synchronize and share their human and material resources as is required to expedite the struggle against the tyrannical regime,
    - 1.3. All parties agreed to cooperate in the areas of capacity building measures like training and Human Resource Development including all extra activities necessary to further trust, confidence, mutual exclusivity, and interdependence between them,
    - 1.4. Agreed to respect the human rights of civilians, prisoners of war as enshrined in the Ethiopian Constitution, applicable International Humanitarian Laws, and the United Nations Declaration on the Rights of Indigenous People.
  - 2. All parties agreed to work on the security arrangement in the event that such an arrangement is needed. Details will be worked out.
  - 3. All have agreed to work jointly to ensure that Eritrean and other foreign Military forces and Security personnel exit from Ethiopia.

4. Agreed to cooperate in their respective diplomatic activities, media and intelligence works.
5. Agreed to maintain a regular consultation at the highest political and military levels, the details of which will be elaborated through organizational channels.
6. Agreed to work jointly towards an all-inclusive national dialogue and the establishment of a transitional arrangement with the view of addressing the political crisis affecting the country.
  - 6.1. Agreed to resolve the political crisis the country is plunged in, including border issues between regions, in the context of the constitution of the Federal Democratic Republic of Ethiopia.
  - 6.2. Agreed to jointly work in apprehending and bringing Ethiopian regime officials and other people involved in gross human rights violations and genocidal crimes to justice.
7. Develop a roadmap to further hammer out and reach a shared understanding and commitment to promoting our mutual interests.
8. Agreed to respect any differences and try to resolving them through dialogue and mutual understanding.

This agreement shall inter into force on the date of signing. **05 November 2021, Washington DC,**
